

WAIVER AND INDEMNIFICATION AGREEMENT

The Red Testament Riding Club (TRT RC)

This Agreement is entered into between the undersigned participant (“Participant”) and The Red Testament Riding Club, its officers, directors, members, ride leaders, volunteers, sponsors, property owners, successors, and assigns (collectively “Released Parties”).

Every guest rider, passenger, and event participant must sign this waiver before participating in any official Club ride or activity. Members sign the full Membership Agreement; this form is the required ride-specific waiver.

1. Assumption of Risk

I understand that motorcycle riding and related activities involve inherent and significant risks of serious bodily injury, permanent disability, paralysis, death, property damage, and economic loss. These risks include, but are not limited to:

- Road, traffic, weather, and surface conditions
- Mechanical failure of motorcycles or equipment
- Actions or omissions of other riders, motorists, or third parties
- Route selection, ride planning, group formation, and group separation
- Emergency response, voluntary first aid, and rescue efforts
- Negligence of the Club, its officers, ride leaders, volunteers, or other participants

I freely and voluntarily assume all such risks, both known and unknown, and accept full responsibility for my participation.

2. Release of Liability

To the fullest extent permitted by Oklahoma law, I release, waive, discharge, and covenant not to sue the Released Parties from any and all liability, claims, demands, actions, and causes of action arising out of or related to any loss, damage, injury (including death), or expense that I or my property may sustain arising from my participation in Club activities, including claims based on the ordinary negligence of the Released Parties.

This release binds me and my heirs, estate, executors, administrators, and family members.

This release does not apply to claims for gross negligence, intentional wrongdoing, fraud, willful injury, or violations of law.

3. Indemnification

I agree to indemnify, defend, and hold harmless the Released Parties from any claims, damages, losses, or expenses (including reasonable attorney fees) arising out of my participation, my own negligence, or my failure to follow Club rules or safety instructions.

4. Representations

I represent that:

- I am at least 18 years of age (or my parent/guardian is signing on my behalf).
- I hold a valid driver's license and motorcycle endorsement if I will operate a motorcycle.
- My motorcycle (if any) is properly registered, insured, and reasonably roadworthy.
- I am not impaired by alcohol, drugs, or any condition that affects my ability to ride safely.

- I have read and understand the Club's basic group-riding expectations.

5. Medical Authorization

In the event of injury, I authorize the Released Parties to obtain emergency medical treatment for me. I understand that I am solely responsible for all medical expenses.

6. Governing Law & Severability

This Agreement is governed by the laws of the State of Oklahoma. If any portion is held invalid, the remainder continues in full force and effect. This Agreement is intended to be as broad and inclusive as permitted by Oklahoma law.

7. Acknowledgment

I have carefully read this Agreement, fully understand its contents, and sign it of my own free will. I understand that I am giving up substantial legal rights, including the right to sue the Released Parties for ordinary negligence.

I acknowledge that this is a release of liability and a binding legal document.
